Background

Allison Everett Pearson grew up near Miles, Iowa. He worked and owned various lumber mills in the area including the John L. Franks and Co. feed mill and lumber yard business with locations in Miles and other local communities. Mr. Pearson passed away in 1966, leaving part of his estate to charitable interests, including the creation of the A.E. Pearson Foundation. The A.E. Pearson Foundation awards contributions to qualified tax-exempt organizations located in Clinton or Jackson County with 501(c)(3) tax status. A bank-appointed Advisory Committee reviews any submitted requests on an annual basis.

Requirements

- Return application and any supporting documents by Tuesday, October 15, 2024 to any Clinton National Bank location or mail to: Clinton National Bank, Attn: Trust Department, PO Box 1510, Clinton, Iowa 52733
- All fields must be completed for request to be considered.
- Applicant must be a 501(c)(3) Internal Revenue Service (IRS) designated organization, religious, or educational institution. If organization is not an educational or religious organization; or, does not have 501(c)(3) tax exempt status, a fiscal sponsor must be secured and supporting documentation provided.
- Organization must be located in Clinton County or Jackson County, Iowa, or serve residents of these counties.
